Artista Creative vacations often sell out at least 60 days in advance, so please confirm availability with us before making travel arrangements. Our rates do not include airfare.

Room & Discount Information: Each room is in a modern hotel with a private bathroom. Rooms are available on a first come, first served basis, so early bookings offer better choices. Of course, stowaway roommates are not permitted. You may choose the Visionary prepaid discount if deposit is made at least 90 days prior to your arrival date. Please, no exceptions for extending Visionary discount deadlines.

Cancellation Policy: "Cancellation" is defined as not attending your scheduled Artista Creative vacation, including postponing or rescheduling. "You" refers to the guest reserving an Artista Creative vacation. "We" refers to Artista Creative vacations for women, a subsidiary of Manifesta Corp. It is your responsibility to read and understand our cancellation policy before making a reservation. Naturally, no one books with the intention of canceling or postponing their vacation, but unexpected things do happen, so please consider purchasing travel cancellation insurance. Depending on the policy and conditions, travel cancellation insurance will pay for some or all cancellation fees. With most agencies, insurance must be purchased within 14 days of making your reservation. We strongly recommend purchasing cancellation insurance through your travel agent, or visit the following website to compare insurers: <http://www.insuremytrip.com>.

If you cancel or change your reservation, Manifesta does not offer cash/check or credit card refunds for any reason. A portion of your payment may be used as credit for another reservation within two years of your original vacation date. We will gladly transfer your credit to another guest and/or Artista Creative vacation. Depending on when you cancel, cancellation fees may apply. Fees are determined by the following schedule: If you cancel more than **90 days** before your vacation start date, 100% of your payment may be applied to another Artista Creative vacation. If you cancel **60 - 89 days** before your vacation start date, 70% of your payment may be applied to another Artista Creative vacation. You will forfeit 30% of the price of your vacation. If you cancel **15 - 59 days** before your vacation start date, 40% of your payment may be applied to another Artista Creative vacation. You will forfeit 60% of the price of your vacation. If you cancel **14 days** or less before your vacation start date, you will forfeit your entire payment. Exceptions to our policy cannot be made for any reason, including weather, injury, or personal emergencies. We do not offer credit for arriving late or leaving early. You must submit your signed Reservation Form and Participant Agreement, Release, and Assumption of All Risks Form within one week of reserving your vacation or 90 days prior to your vacation start date, whichever comes later. Guests who fail to do so, may be subject to an automatic cancellation and the above policy will apply.

If we cancel or change your vacation, you may transfer your full payment to another vacation, or you may request a refund of your payments to us, constituting a full settlement. Artista Creative is not responsible for your expenses incurred in preparation for any canceled vacation, such as airline tickets, loss of work, and/or other costs associated with preparing for your trip.

Participant Agreement, Release, And Assumption Of Risk



In consideration of the services offered by Manifesta Corporation dba Artista Creative Vacations for Women and our associates including the Cypress Inn and their affiliates, agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Manifesta"), I hereby agree to release, indemnify, and discharge Manifesta, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that activity entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: Falling which could result in cuts, bruises, abrasions, or concussions; sprains, strains, broken bones, paralysis, even death. Furthermore, Manifesta instructors and staff has difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks, known or unknown.
3. I understand, that should I become disruptive to the program, rude or abusive to Manifesta guests or staff, create discomfort for other guests, or disregard safety standards, I may be asked to leave without compensation. Manifesta reserves the right to refuse service to anyone.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Manifesta from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Manifesta's equipment or facilities, including any such claims which allege negligent acts or omissions of Manifesta.
5. Should Manifesta or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
6. I certify that I have adequate insurance to cover any injury or damage I may suffer or cause while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
7. In the event that I file a lawsuit against Manifesta, I agree to do so solely in the state of California, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
8. I understand that artistic painting requires the use materials that may effect me adversely and although Manifesta will do their best to mitigate those effects, negative reactions to the painting process does not constitute a refund. I understand that weather, terrain, and other natural conditions including exposure to insects and micro-organisms such as bacteria and viruses are an inherent risk while on vacation and are therefore not grounds for a refund.
9. I understand that from time to time, photographers may take photos of guests for use in promotional materials such as websites, advertisements, catalogs, and magazine editorial. I do not expect any compensation for such use. If I do not want my photograph taken I will inform a representative of Manifesta.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Manifesta on the basis of any claim from which I have released them herein.
